



REGULATIONS 2013 EDITION

In memory of Cardinal Carlo Maria Martini (Turin 15/2/1927 – Gallarate 31/8/2012) and following in the wake of his teachings, the Archdiocese of Milan, of which he was Archbishop from 1980 to 2002, has established an International Award in his name.

THE THEMES

The Award is divided into two categories, and will be assigned to written works and/or projects that contribute to:

- The study and knowledge of the thoughts of Cardinal Carlo Maria Martini.
- Or, the development of the fruitful relationship between the Bible and culture in its different spheres: art, literature, philosophy, science, economics, politics, religion, the performing arts, etc.

Published works must have been published after 31/12/2010. Unpublished works must be completed and ready for printing, together with finalised illustrations, if any, and, the author must be the legal owner of all intellectual property. The initiatives should have already commenced before 31/12/2012.

ELIGIBILITY CRITERIA

The Award is open to all Italian and foreign citizens who were born before 31/08/1995 and who present their entries, initiatives and/or written works, they wish to submit, in accordance with the provisions of these terms and conditions.

The deadline for all entries is August 31, 2013

Written works and initiatives, which must be exclusively in electronic format and not exceed 2GB, shall be submitted to: info@martiniaward.it or “Premio Carlo Maria Martini”, Curia Arcivescovile, Piazza Fontana, 2, 20122 Milan (MI), Italy.

The presentation may be in Italian or English. Other languages cannot be accepted.

Each single project may be presented by a team of a maximum of four persons.

Each entrant must submit:

- The Entry Form and Data Protection Consent Form (in pdf/jpg/peg format).
- Copy of a valid identity document (in pdf/jpg/peg format).
- Copy of the tax code or equivalent document (in pdf/jpg/peg format).
- Their curriculum vitae (maximum 2 pages).

THE AWARDS

Four cash prizes of € 5,000 each will be awarded.

In the event of a tie, the prize will be divided in equal parts between the two or more winners. Special prizes may be awarded at the discretion of the Judging Panel, and the Judging Panel's decision is final. In the event of there being no suitable winner of the Award, the outstanding amount will remain at the disposal of the Archdiocese of Milan.

GUIDELINES FOR THE SUBMISSION OF ENTRIES

1. The written work and/or initiative submitted to the Award must have a title. The entrant must also prepare a brief description (maximum 700 characters) of the contents and purpose.
2. In the description, the following must be clearly defined:
 - a) The section you wish to enter, and, for the second section, the cultural area or areas chosen.
 - b) The individual(s) submitting the entry and whether the initiative is connected with other projects already in progress.
 - c) Whether the written work or initiative has already been entered in other competitions and whether it won.

ANNOUNCEMENT OF THE RESULTS

The top projects will be presented to the authorities at the Award ceremony, which takes place in Milan (Italy) by December 31, 2013.

THE JUDGING PANEL

The Judging Panel, whose decision is final, is made up of five members appointed by the Archbishop of Milan.

PROVISIONS AND RIGHTS

Entrance to the Award requires full compliance with the provisions of these terms and conditions. In the event of default of even just one of the provisions, the entrant shall automatically be disqualified from the Award, with no obligation of the organisers to inform the defaulters thereof.

Upon accepting these terms and conditions, the entrant:

1. Grants his consent to the free use of the works or part of the works submitted, without limit of time, for all the activities related to the Award, its promotion and publication of results, in any form, way and media, (as, for example, brochures, leaflets, web site), even when such activities are carried out together with third parties.
2. Releases the Award organisers from any liability arising from the material sent.
3. Acknowledges that the materials submitted will not be returned to their authors by the Award organisers.
4. Declares that they expressly waive all rights to compensation for the use – related to the Award – of the works or part of the works submitted.

DATA PROTECTION

The personal data submitted by the entrants for the purpose of the Award, or personal data otherwise collected to this end by the Archdiocese of Milan, shall be used solely for the purposes of administering the Award. It is compulsory to complete and return the attached forms (ENTRY FORM AND DATA PROTECTION CONSENT FORM). The data collected shall not be published or passed on to third parties for any reason.

DATA PROTECTION CONSENT FORM

Excerpt from Law Decree 30/6/2003 TITLE II – (DATA SUBJECT’S RIGHTS)

Section 7 (Right to Access Personal Data and Other Rights)

1. A data subject shall have the right to obtain confirmation as to whether or not personal data concerning him exist, regardless of their being already recorded, and communication of such data in intelligible form.

2. A data subject shall have the right to be informed a) of the source of the personal data; b) of the purposes and methods of the processing; c) of the logic applied to the processing, if the latter is carried out with the aid of electronic means; d) of the identification data concerning the data controller, data processors and representative designated as per Section 5(2); e) of the entities or categories of entity to whom or which the personal data may be communicated and who or which may get to know said data in their capacity as designated representative(s) in the State’s territory, data processor(s) or person(s) in charge of the processing.

3. A data subject shall have the right to obtain a) updating, rectification or, where interested therein, integration of the data; b) erasure, anonymization or blocking of data that have been processed unlawfully, including data whose retention is unnecessary for the purposes for which they have been collected or subsequently processed; c) certification to the effect that the operations as per letters a) and b) have been notified, as also related to their contents, to the entities to whom or which the data were communicated or disseminated, unless this requirement proves impossible or involves a manifestly disproportionate effort compared with the right that is to be protected.

4. A data subject shall have the right to object, in whole or in part, a) on legitimate grounds, to the processing of personal data concerning him/her, even though they are relevant to the purpose of the collection; b) to the processing of personal data concerning him/her, where it is carried out for the purpose of sending advertising materials or direct selling or else for the performance of market or commercial communication surveys.
